- Application documents received after application deadlines will not be accepted.
- It is not possible for exchange students to work towards or defend their BA/BSc/MA/MSc/PhD thesis at the host university.
- It is not possible for exchange students to carry out placements or traineeships at the host university.
- Incoming international staff should apply for visits to the departmental coordinator of the respective faculty.
- Applicants should not arrange travel or accommodation until they have received an official offer from the host university.

- 2. The receiving institution will send its decision within4 weeks.
- 3. A Transcript of Records will be issued by the receiving institution no later than 4 weeks after the assessment period has finished at the receiving HEI.
- 4. Termination of the agreement

In the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."]
